DURING THE PERIOD OF JANUARY 1, 2021 THROUGH DECEMBER 31, 2021, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,033,915.12 OF THE COUNTY 2021 REAL ESTATE TAX AND \$6,168.05 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 88.0% OF THE TOTAL BILLED FOR THE 2021 REAL ESTATE TAX AND 81.0% OF THE TOTAL BILLED FOR THE 2021 PER CAPITA TAX.
