Mr. Preston made a motion to approve the Natural Gas Procurement Services Contract for the period November 1, 2011, thru October 2012, with National Fuel Resources, Inc. as the provider at the cost of .408/Dth. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the refund of \$451.44 (\$435.60 county refund and \$15.84 library refund) to Donald Bortnik for the over assessment on his property in Conneaut Township for the years 2005-2010. Mr. Preston seconded the motion and it carried.

Mr. Preston made a motion to approve the ratification of the 2011 Community Development Block Grant Application in the amount of \$298,499.00. The projects that were approved were the Conneautville waterline replacement project in the amount of \$244.770.00, the final 2010 comprehensive plan update in the amount of \$8,026.00, and administrative funding in the amount of \$45,703.00. Mr. Preston made a motion to approve the fiscal year 2012 Hazardous Materials Emergency Preparedness (HEMAP) Planning and Training Grant Application. The annual grant is administered by the United States Department of Transportation and funneled thru the Pennsylvania Emergency Management Agency to the County. For the project year they would like to develop transportation response plan based on templates provided by the state, and conduct additional exercises that would test those plans. They would like to send a person to the Hazmat Tech conference next year and would also like to conduct some more HAZMAT training for the first responders in the county. Also purchase and install a used tank trailer training prop at the Crawford Venango fire school grounds in Cambridge Springs. The Grant application is in the amount of \$35,500.00. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the ESRI maintenance for November 1, 2011 thru December 31, 2011, in the amount of \$3,459.45. This is a GIS Software Maintenance agreement for OES, Planning and the Assessment office. Mr. Preston seconded the motion and it carried. Mr. Preston made a motion to approve the purchase of the Comodo EV SSL Security Certificate for on the server for the crawfordcountypa.net domain, which allows putting secure encryption on the system, in the amount of \$299.80 for one year, for the Information Technology Department. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion for a renewal of the Symatec Enterprise Vault and e-Discovery software one-year maintenance in the amount for \$11,632.50, for the Information Technology Department. Mr. Preston seconded the motion and it carried.
