The meeting was opened with the Pledge of Allegiance.

Mr. Allen made a motion to approve the January 17, 2013 and February 5, 2013 meeting minutes. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to approve the payment of bills in the amount of \$3,306,476.81 for the period ending February 6, 2013. Mr. Allen seconded the motion and it carried.

Mr. Weiderspahn announced that there were two executive sessions one on February 4, 2013 for Litigation and Personnel and one on February 5, 2013 for Real Estate.

Mr. Allen made a motion to approve the purchase of 5,000 Teslin cards and sleeves for the License to Carry Permits issued by the Sheriff's office, from IRIS Companies at a cost of \$1,950.00, this will be paid for with Records Improvement Funds. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to ratify the Letter of Acceptance for the Victim/Witness Services Grant in the amount of \$86,000.00 for the period of January 1, 2013 to December 31, 2014. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the Retainer for Forensic Pathologist Services with the County of Erie in the amount of \$7,000.00, \$5,000.00 from the Coroner and \$2,000.00 from the District Attorney. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to ratify the purchase of 13,824 flags for use in the County Cemeteries at a cost of \$7,050.24; these flags are made in Pennsylvania for the Veteran's Services office. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the Memorandum of Understanding with the American Red Cross for a period of 5 years (for use in a large scale emergency) starting this date until January 1, 2018, pending solicitor review. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to approve the Memorandum of Understanding with Crawford Area Transportation Authority (CATA) for transportation services in case of a large scale emergency, pending solicitor review. Mr. Allen seconded the motion and it carried.

Mr. Clark along with Mr. Chion, Mr. Borchilo and Mr. McCaskey presented a sign to the Commissioners stating that the County is a Storm Ready County.

Mr. Lynch made a motion to approve the purchase of APCO Online Continuing Education Program for 19 911 employees for a total of \$1,881.00. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve an agreement with Conneaut Lake Borough for an antenna to be placed on the Boroughs water tower to help with radio transmission with no cost to the county. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to approve the purchase of an advertisement in the Windstream Phonebook at a cost of \$490.47 per month. This purchase covers listing in both white and yellow pages for the Crawford County Care Center. Mr. Allen seconded the motion. The vote was called with Mr. Lynch and Mr. Weiderspahn voting yes and Mr. Allen voting no, motion carried.

Mr. Allen made a motion to approve the creation of an Assistant Director of Nursing position. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to approve the Project Modification for the Drug & Alcohol Restorative Intermediate Punishment (RIP) Grant to return \$78,206.00 to the state since the number of participants is the same as pervious years; the fund expended should remain consistent with previous years, for the Adult Probation Department. Mr. Allen seconded the motion and it carried.

Mr. Lynch made a motion to approve the purchase of Crucial Memory, Printers, Memory, Monitor, Cables, Adapters, Graphics Cards, and Graphics Adapter from IMR Document Imaging

in the amount of \$5,842.89 for the Clerk of Courts and the Recorder of Deeds offices. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the Register and Recorders Office to sell images to ACS Software in the amount of \$2,550 per year. Mr. Lynch seconded the motion and it carried.

Mr. Lynch made a motion to ratify the Stay of Sale/Hardship Policy for the Tax Claim Bureau Sales. Mr. Allen seconded the motion and it carried.

Mr. Allen made a motion to approve the County Purchasing Policy with noted revision for the Restricted Care Center Funds. Mr. Lynch seconded the motion and it carried.
