Mr. Soff made a motion to approve the FY 19/20 CYS/JPO contract amendment with Bethesda Lutheran Services for the delivery of foster care services for up to six children ages 5-11. Cost to the county is \$29.13 per day. Mr. Weiderspahn seconded and the motion carried.
