Mr. Soff made a motion to approve the minutes from the full meeting held on March 24, 2021.

Mr. Soff made a motion to approve the payment of bills in the amount of \$11,861,022.43 for the period ending April 13, 2021. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to ratify the State Offender Supervision Fund Agreement Renewal. This is a one-year renewal for the period of July 1, 2020 through June 30, 2021. The state contract commenced on July 1, 2017 and runs through to June 30, 2022. The PA Parole Board will return to Crawford County the Offender Supervision Fees that were received by the Department of Revenue from Crawford County for the period of May 1, 2020 to April 30, 2021. Mr. Soff made a motion to approve the purchase and installation of an electronic ZK Access control system for the front and rear entry doors to the JPO department. This includes a one-year maintenance coverage on all parts and labor. The system will allow secure access to the building with keyless entry and badge access. This system will be incorporated with the existing system at the courthouse and Judicial Center. The purchase and installation amount is \$3,998.00. The funds to pay for this are being transferred from the previously approved budgeted amount for new laptops computers for JPO. The laptops instead were purchased through money awarded through the CJAB grant. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to ratify the 5-year subscription to the West's Pennsylvania Criminal Justice Book & Proview Pennsylvania Criminal Justice Book (6 of each) for the annual payment in the amount of \$1,440.00 (3% increase per year). Mr. Soff seconded and the motion carried.
