## Official Business:

Mr. Weiderspahn made a motion to approve the updated service agreement with Pennsylvania Department of General Services-DGS COSTARS, BI Incorporated and Crawford County Juvenile Probation. This annual service contract is for the electronic monitoring program and specifies equipment rental costs, repairs and monitoring service charges for the house arrest electronic monitoring program with Juvenile Probation. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the purchase of a contact management system from LegalEdge. Cost is projected to be total of \$18,700 for set-up fee and annual maintenance. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to approve the purchase of two Soft Codec Conferencing Systems (QSC Video Conferencing) from Horizon Information Services for Courtrooms 2 & 3, each system for \$15,021 for a total cost of \$30,042.00. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the purchase of (2) -Vests and Carriers for County Security Officers and (1) -Vest and Carrier for the Sheriff. Total purchase amount is \$2,633.92. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion ratify the transfer of the ARPA Funds in the amount of \$8,219,095.50 to the new MMA account at Mercer County State Bank. A portion of the funds will be moved to short term investments after more direction on how the funds will be used here in the County. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the purchase of a SureGuard Correctional Chair. The SureGuard Safety Restraint Chair is intended to help control combative, self-destructive, or potentially violent detainees. If used properly it can reduce the risk of physical harm to both the detainee and staff. Violent behavior may mask dangerous medical conditions; therefore, detainees must be monitored for and provided with medical treatment if needed. The restraint chairs currently used are not conducive for medical treatment. Nor are they as humane as the SureGuard Safety Restraint Chair. Cost per chair is \$2,334.37 purchased from Bob Barker. To be paid thru Commissary funds. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to approve the purchase of new roof top heating and air condition units. (16 RTUs) The new RTUs will be equipped with UVC lighting that is 99% effective in killing bacteria, viruses and germs. All RTUs, needed parts and equipment will be purchased from RE Michaels. Total purchase price is \$123,942.80. Approximately \$13,500 cheaper than the next nearest quote. To be paid thru the COVID-19 funding. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to ratify the annual Hazardous Materials Response Fund grant application submitted to PEMA in the amount of \$17,271.00. Will purchase calibration cylinders, docking stations and cylinder holders to enhance the twenty multi-gas detectors purchased last year and disbursed to numerous Crawford County based Fire Departments. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to approve the purchase and installation of additional ambient light fixtures and remote operation switches above six 911 consoles at a cost of \$1,788.00. Work to be completed by Mark Johnson Electrical Contracting. This expense is paid for with wireless funds at no additional expense to the county. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the updated Hazardous Materials Incident Cost Recovery Policy. Mr. Weiderspahn seconded and the motion carried.

Mr. Weiderspahn made a motion to ratify the contract with Livanta, an agreement required by Medicare. Mr. Soff seconded and the motion carried.
