US FISH AND WILDLIFE SERVICE

The U.S. Fish and Wildlife Service is proposing a new National Wildlife Refuge to be located in portions of Chautauqua County in New York and in Pennsylvania, Erie, Venango, Crawford and Mercer Counties. The refuge would protect high quality habitat needed for threatened and endangered freshwater mussels and the remarkable aquatic biodiversity of French Creek and its tributaries. In April, the Service will be seeking public comment on the proposed refuge. One of those locations will be in Meadville at Allegheny College. ACT 13 PROGRAM

Legislative Updates

(Shared via email on 4/28/23 after the Regular Meeting) House Bill 782 –

This is an amendment to the MPC (Municipality Planning Code) which is the legislation that authorizes planning in PA. The bill ultimately identifies certain development as a "development of regional impact" and mandates developers to submit an impact analysis to the communities. The impact analysis would include, but is not limited to, housing, traffic, economic, environmental, mitigation plan (emergency services), and coordination of state agencies. The bill is derived from a joint state committee report from over a decade ago which was not fully vetted to the point of language for a piece of legislation. The PA APA is recommending the bill be further evaluated prior to action. We believe it may cause undesirable delays in the development review process and become laborious for local governments who lack capacity.

Additionally, there are two new pieces of legislation that are under development: one federal and one state. These deal with land banks and taxation collection for communities. As more information becomes available, it will be shared with the Planning Commission and Planning Office Staff.]
