# COUNTY COMPREHENSIVE PLAN UPDATE

# ACT 13 PROGRAM

Crawford County will award the Act 13 projects presented to the Board of Commissioners. A total of seven projects are being recommended for funding. Act 13 At-Risk Bridge grant awards • City of Meadville – Bridge No. 12 – Clinton Court over Mill Run -\$48,175.00 • Wayne Township – Rynd Road Culvert Replacement - \$15,061.50 Act 13 Environmental Initiative grant awards • Bloomfield Township Sewage Authority—Canadohta Lake Sewage/Oil Creek Pollution Prevention - \$46,250.00 • French Creek Recreational Trails—Ernst Trail Connector Paving - \$73,400.00 • West Mead Township—Oakgrove Park Playground Enhancements -\$3,637.73 • Northwest PA Mobility

Alliance—Titusville Bike Share program -\$12,500.00 • Western Pennsylvania Conservancy—Tryon-Weber Woods Natural Area Access Improvements and Stream Restoration, Phase Two - \$17,235.00

#### CDBG PROGRAM

Crawford County held both the City of Titusville and County CDBG public hearings for the 2023 application. Staff have spoken with numerous communities about the funding stream and expects to receive at least one or two project ideas. Project ideas are due to Crawford County by June 30, 2023. # Legislative Updates

#### ACT 149 OF 2022

Act 149 removes the ten-year time limit on a county's ability to collect a blight demolition fee as previously authorized under Act 152 of 2016. The ability to collect funds would have been eliminated in 2026; however, Act 149 removed the deadline allow counties to have a dedicated way of funding a demolition program should they choose to do so.

#### PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION – PCSM MANUAL

The DEP has proposed a new Post-Construction Stormwater Manual which industry leaders and planners across the commonwealth are concerns will be excessive and increase the cost of development as well as delay projects. We see local communities struggle to comply with administering the existing regulations, so newer stricter requirements will only further exasperate the problem.

# HOUSE BILL 123 – SIGNAGE REQUIREMENTS FOR SUBDIVISION AND LAND DEVELOPMENT

A proposed Act would amend the PA MPC to require signs to be posted on land undergoing subdivision and land development. The bill would provide specific size requirements for posted signage on property being developed, thereby providing residents with a better understanding of development occurring within the community. PA APA legislative committee is discussing recommended revisions to the bill in an effort to make the law more impactful and less redundant.

# HOUSE BILL 782 - TIME TO FIGHT BACK FOR COMMUNITIES

The proposed bill would amend the PA MPC to address developments of regional significance by changing the law to: • require mega-development developers to provide a detailed analysis of the impacts of development, including the real cost on traffic, future infrastructure costs, emergency management services, sewer, storm water, damage to agricultural lands, parks and open space, impact on neighborhoods, natural resources and wildlife and harm to neighboring properties • allow the host municipality to use this analysis to consider conditions which address the impacts and costs of the development; and • give neighboring municipalities the opportunity to have their concerns addressed.] Discussion.
