## Crawford County Fire Commission MINUTES

July 19, 2023, 7:00pm

- I. Commissioner's Welcome Crawford County Commissioner Eric Henry welcomed members and guests to the Fire Commission meeting.
- II. Roll Call of Commission Members Members attending were; Clark, Coston, Fuller, Horvat, McCartney, Pratt, Sekerski, Smock, Treacy, Wimer, and Brown. DPS Director Greg Beveridge and Operations and Training Officer Don Bovard. Guests attending were; Scott Schell, Dan Bresee and Cody Turner from Cochranton Fire Dept., and Ryan Zook from West Mead #1 Fire Dept.
- III. Subcommittee Reports
  - a. Communications: Chair John Treacy, Jim Pratt, Joe Smock, Kris Simmons, and Greg Beveridge

John Treacy reported that some departments still do not want to use IAR and other departments use it to the fullest and feel it is a valuable tool.

DPS Director Greg Beveridge reported that the two tone detect audio play through IAR will be released soon with a couple more steps to complete. The audio of the initial dispatch can be played over your phone through the IAR App. CAD View will have a new version soon with improvements to how it looks and functions for the end users. There may be a user's course available on-line. Prepared Live is a text message to 911 for hang up calls. 911 can also receive live video from callers and will be able to push that to MDT's in the near future. ASAP to PSAP is a system where alarm companies' data can be directly sent to the 911 center making it quicker to receive information. The 911 Center is hiring 1 full time and 2 part time 32-hour positions if anyone knows anyone that is interested. There is 720 hours of training to become a telecommunicator.

Jim Pratt commented how good the new software is in showing where the address of the call is and the caller.

The same agencies are always on regional notification as OOS or Limited. Director Beveridge said that everyone with IAR can look on their app to see real time who is OOS or in limited status. The important thing is the ability to see the status of every fire and EMS department in the county. A question was asked if fire and EMS departments can mark themselves OOS or Limited on the IAR APP instead of calling into the 911 Center. Greg will ask IAR.

Motion by Phil Koon and second by Bob Wimer to extend to 10 minutes to acknowledge on all non-emergency incidents i.e., trees down. Motion passed unanimously. Greg will take this suggestion to the 911 shift leaders meeting. Greg reported that during the day the 911 center does contact the municipality on trees down.

b. Government: Chair Maryann Menanno, Rob Horvat, Eric Coston, Don Bovard, and Justin Sullivan

Vernon Township Supervisors adopted tax relief for their fire department members living in the township. Vernon Central tracks members hours and calls. To qualify members must make 50 calls and attend twelve hours of training per year. \$500 earned income credit. Robie met with the Crawford County Commissioners regarding tax credit for all fire and EMS in the County. Robie Horvat to become the new Chair of the Government Subcommittee.

Lift Assists: Director Beveridge reported that the EMS Commission saw a presentation on MDALLY which is telehealth system that 911 can transfer certain calls to for assistance instead of sending an ambulance. The projected benefit would be at least one call a day would qualify for this service. He is waiting to hear back from the company on the next steps. MDALLY has a doctor talk with the caller immediately and can call in a prescription, arrange for a local doctor's appointment, or arrange for transportation to the doctors. The company bills the patient's insurance company.

Commissioner Henry reported that Active Aging is working on a system for their employees to handle lift assists in the county. They have trained people that can assist residents. The only downfall is that the patient can refuse Active Aging help. MMC has a follow up nurse that call patients after hospitalization. They are hoping to have this system in place by January 1, 2024

Commissioner Henry had a meeting with CATA with their CATA GO program residents can ride the bus for \$1.50 a trip. There are 58 stops in Titusville alone so residents can take a bus to the doctors or hospital if their condition is non-emergency. It was reported that some fire departments charge \$100 for lift assists which they invoice the patient.

A meeting will be scheduled with Kim Flynn for marketing ideas for recruitment. The Crawford County Technical School and Allegheny College students can help develop some media items. It was suggested to have public announcements during the Crawford County Fair and have banners to promote the fire and EMS departments in the county.
