# COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2016 THROUGH DECEMBER 31, 2016, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$898,672.36 OF THE COUNTY 2016 REAL ESTATE TAX AND \$7,905.95 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 86.5% OF THE TOTAL BILLED FOR THE 2016 REAL ESTATE TAX AND 75.5% OF THE TOTAL BILLED FOR THE 2016 PER CAPITA TAX.

### D. COUNTY HOTEL EXCISE TAX

CRAWFORD COUNTY COLLECTED \$279,490.18 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2015 THROUGH OCTOBER 31, 2016. \$272,877.68 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$6,612.50 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
