DURING THE PERIOD OF JANUARY 1, 2019 THROUGH DECEMBER 31, 2019, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,046,574,43 OF THE COUNTY 2019 REAL ESTATE TAX AND \$6,772.10 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 87.0% OF THE TOTAL BILLED FOR THE 2019 REAL ESTATE TAX AND 78.5% OF THE TOTAL BILLED FOR THE 2019 PER CAPITA TAX.
