
COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2021 THROUGH DECEMBER 31, 2022, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,041,301.58 OF THE COUNTY 2022 REAL ESTATE TAX AND \$5,748.40 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 90.0% OF THE TOTAL BILLED FOR THE 2022 REAL ESTATE TAX AND 72.0% OF THE TOTAL BILLED FOR THE 2022 PER CAPITA TAX.

D. COUNTY HOTEL EXCISE TAX

CRAWFORD COUNTY COLLECTED \$504,907.77 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2021 THROUGH OCTOBER 31, 2022. \$484,711.46 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$20,196.32 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
