## COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2023 THROUGH DECEMBER 31, 2023, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,024,122.08 OF THE COUNTY 2023 REAL ESTATE TAX AND \$9,373.80 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 81.0% OF THE TOTAL BILLED FOR THE 2023 REAL ESTATE TAX AND 91.0% OF THE TOTAL BILLED FOR THE 2023 PER CAPITA TAX.

## D. COUNTY HOTEL EXCISE TAX

DISTRIBUTION TOTALS

CRAWFORD COUNTY COLLECTED \$485,164.69 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2022 THROUGH OCTOBER 31, 2023. \$465,758.13 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$19,406.57 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
