DURING THE PERIOD OF JANUARY 1, 2024 THROUGH DECEMBER 31, 2024, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,053,848.50 OF THE COUNTY 2024 REAL ESTATE TAX AND \$9,423.85 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 84.0% OF THE TOTAL BILLED FOR THE 2024 REAL ESTATE TAX AND 75.0% OF THE TOTAL BILLED FOR THE 2024 PER CAPITA TAX.

D. <u>COUNTY HOTEL EXCISE TAX</u>
