**COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE**

During the period of January 1, 2022 through March 31, 2022, Crawford County Treasurer's office collected \$205,553.91 of the county 2022 Real Estate tax and \$000.000.00 of the county Per Capita tax for the city of Titusville. Collected amounts represent 18.0% of the total billed for the 2022 Real Estate tax and 00% of the total billed for the 2022 Per Capita tax

**D. COUNTY HOTEL EXCISE TAX**

Crawford County collected \$75,006.47 from the Hotel Excise Tax for the period of January 1, 2022 through March 31, 2022. \$72,006.21 was submitted to the Crawford County Tourist and Visitors Bureau. A \$3,000.26 commission from the Hotel Excise Tax was earned by the county for the period.
