A. <b><u>LICENSES:</u></b>

From these licenses and permits a commission was returned to Crawford County Commissioners in the amount of \$ 11,291.50.

**B. INTEREST REVENUE**


**COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE**

During the period of January 1, 2021 through March 31, 2021, Crawford County Treasurer's office collected \$220,442.89 of the county 2021 Real Estate tax and \$000.000.00 of the county Per Capita tax for the city of Titusville. Collected amounts represent 19.5% of the total billed for the 2021 Real Estate tax and 00% of the total billed for the 2021 Per Capita tax

**D. COUNTY HOTEL EXCISE TAX**

Crawford County collected \$52,292.20 from the Hotel Excise Tax for the period of January 1, 2021 through March 31, 2021. \$50,200.52 was submitted to the Crawford County Tourist and Visitors Bureau. A \$2,091.69 commission from the Hotel Excise Tax was earned by the county for the period.
