
COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2017 THROUGH DECEMBER 31, 2017, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$908,538.73 OF THE COUNTY 2017 REAL ESTATE TAX AND \$7,629.25 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 87.0% OF THE TOTAL BILLED FOR THE 2017 REAL ESTATE TAX AND 79.5% OF THE TOTAL BILLED FOR THE 2017 PER CAPITA TAX.

D. COUNTY HOTEL EXCISE TAX

CRAWFORD COUNTY COLLECTED \$382,068.99 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2016 THROUGH OCTOBER 31, 2017. \$366,786.23 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$15,286.76 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
