COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2018 THROUGH DECEMBER 31, 2018, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$897,805.41 OF THE COUNTY 2018 REAL ESTATE TAX AND \$6,819.80 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 85.0% OF THE TOTAL BILLED FOR THE 2018 REAL ESTATE TAX AND 75.5% OF THE TOTAL BILLED FOR THE 2018 PER CAPITA TAX.

D. COUNTY HOTEL EXCISE TAX

CRAWFORD COUNTY COLLECTED \$412,068.99 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2017 THROUGH OCTOBER 31, 2018. \$396,293.19 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$16,512.21 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
