1. To vote, you **MUST BLACKEN THE OVAL (●) COMPLETELY**. An oval blackened to the left of the name of a candidate indicates a vote for that candidate.
2. To cast a write-in vote for **A PERSON WHOSE NAME IS NOT ON THE BALLOT**, you must darken the oval on the left of the write-in box and print the name in the space provided.
3. Please use a black ball point pen.
4. If you make a mistake, **DO NOT ERASE**. Ask for a new ballot.
