IMPORTANT NOTICE

Please read this notice before requesting a custody trial!

A custody trial is a formal legal proceeding in a courtroom before a Common Pleas Judge (not the Conference Officer). Unlike the custody conference, the trial is "on the record," meaning that a court reporter will be recording all of the testimony.

THE TRIAL IS NOT A SECOND CUSTODY CONFERENCE

At the custody trial, you will be required to follow formal courtroom procedures and all court rules for trials, including all rules governing the presentation of evidence – whether or not you have an attorney.

You must bring with you all witnesses you intend to call in your case, and any children who you feel the judge should talk to. Also, if you are residing with another adult who, therefore, interacts with the child(ren), you should have that person available to testify.

Your witnesses will be required to swear or affirm that they will give truthful testimony, and they may be questioned by any other party in this custody action (or by the party's attorney, if represented by counsel).

Once you file a request for a trial, you can only withdraw your request if you have the consent of all other parties in the custody action.
