Mr. Preston made a motion to approve the payment of bills in the amount of \$1,156,194.70 for the period ending November 16, 2011. Mr. Allen seconded the motion and it carried. Mr. Allen then qualified his vote by stating that he was protesting any payment concerning the Talon 5 Building.

There was no executive session for the period.

Mr. Allen made a motion to approve the re-appointment of Sarah Sargent to the Position of Urban Director to the Crawford County Conservation District Board. Mr. Preston seconded the motion and it carried.

Mr. Preston made a motion to approve the Resolution for the reauthorization of the County Agricultural Easement Purchase Program (Farmland Preservation). Mr. Allen seconded the motion and it carried.

Mr. Preston made a motion to approve the re-appointment of John Tautin to the Farmland Preservation Board for a three-year term, beginning January 1, 2012 to January 1, 2015. Mr. Allen seconded the motion and it carried.
