The total grant amount requested is \$30,000. This is all state funds with no county match. Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to approve the Purchase Requisition – Center for Family Services for the County Food Pantry. Total amount of requisition - \$7,404.00. Cost to the county - \$395.29. Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to approve the Purchase Requisition – Crawford County Drug and Alcohol Executive Commission – for reimbursement for the Hidden in Plain Sight trailer event. Total Cost - \$1,000 paid with SOC grant funds. NO cost to the county. Mr. Weiderspahn seconded and the motion carried.

- FY 19/20 Professional contract with Walter J. Miller for the delivery of constable services.

Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to ratify the 36-month renewal of Sophos Firewall maintenance for Veterans Services Office. Renewal cost is \$1,549.00 but a preferred customer discount of \$278.82 is provided so final cost to the county is \$1,270.18. This is being renewed through Candoris. Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to approve the renewal of the annual database Consulting Support Services with USIT starting 1 January 2020 through 31 December 2020. We reduced this agreement from a not to exceed value of \$20,000 to \$10,000 for 2020 and added support for Microsoft SQL databases at a cost of \$120 per hour since they now provide support for it and most of our databases use this software. The cost per hour of their Oracle support remains \$165 per hour. Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to approve the procurement and installation of 2 Workstations for the Correctional Facility Security Camera System. Total cost is \$4,535.00 which is less than what was approved for Mobilcom before they terminated their support for the system. The systems will be procured and installed by Horizon. Mr. Weiderspahn seconded and the motion carried.

Mr. Soff made a motion to ratify work done by Avanco International to get the HS Fiscal module of ICAMs moved from a Windows Server 2008 to a new 2016 Windows Server. This was required to be completed prior to January 14th, 2020. Mr. Weiderspahn seconded and the motion carried.
