Mr. Amato made a motion to approve the FY 19/20 CYS/JP Contract with Bethany Christian Services of Central Pennsylvania-- These are the same services that we contract for in FY 18/19; the rates are 1.75 - 2.00% higher than last year. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the FY 19/20 CYS/JP Contract with Child to Family Connections, Inc. - These are the same services that we contracted for in FY 18/19; the rates for FF and GG remain the same as the prior year, while the rates for AA - EE received a 3.0 - 4.7% increase. Mr. Amato seconded and the motion carried.

Mr. Amato made a motion to approve the FY 19/20 CYS/JP Contract with the Bair Foundation of Pennsylvania - These are the same services that we contracted for in FY 18/19; the rates for BG and Best for Families remain the same, while the remaining foster care rates increased by 1.5 – 4.2%. The increases were to support the cost of all families and supervisors being certified in Structured Analysis Family Evaluation (SAFE), an evidence-based assessment tool. Mr. Soff seconded and the motion carried.

Mr. Soff made a motion to approve the FY 19/20 MH Contract with Family Services of Northwestern Pennsylvania – Both FBMH rates remain the same as the prior year. We are increasing the contract maximum for FBMH from \$5,578.20 to \$17,209.71, as the program has not been operating at capacity, but the provider is hoping to be fully staffed with four teams in FY 19/20. Mr. Amato seconded and the motion carried.

Mr. Amato made a motion to approve the 19/20 CYS/JP Contract with Children's Aid Society of Mercer County - Services and rates are the same as FY 18/19. This agency provides foster care services. Mr. Soff seconded and the motion carried.

Mr. Amato made a motion to approve the 19/20 CYS/JP Contract with Edmund L. Thomas Adolescent Center - Services and rates are the same as FY 18/19. This agency provides Detention Center services. Mr. Soff seconded and the motion carried.
