THIS PACKET DOES NOT CONSTITUTE LEGAL ADVICE. IF YOU HAVE ANY QUESTIONS ABOUT THIS PROCESS, YOU SHOULD SEEK THE ADVICE OF AN ATTORNEY. THE COURT ASSUMES NO RESPONSIBILITY AND ACCEPTS NO LIABILITY FOR ACTIONS TAKEN BY USERS OF THESE DOCUMENTS, INCLUDING RELIANCE ON THEIR CONTENTS.

We encourage you to contact an attorney to advise you on this matter. If you cannot afford an attorney, the Court will not appoint an attorney for you. You may contact Northwestern Legal Services at (800) 665-6957 or (814) 724-1040 to see if they will provide free legal services to you. They are not obligated to do so.

You will be required to follow the State and Crawford County Rules of Civil Procedure and all applicable laws even if you do not have an attorney.

This form is for use in two situations:

1. Maintaining the status quo pending mediation. This Motion is appropriate when there is no existing Custody Order, but the parents were following a custody arrangement that one of the parents suddenly changed. The moving party <u>must</u> file a custody action and request mediation before filing a motion requesting relief in Custody Motion Court.

OR

2. If there is a true emergency. This means the child(ren) is/are in physical danger, or you can prove that the other parent is going to remove the child(ren) from the country so an order entered here may not be able to get the child(ren) back. If there is no custody case for the child(ren), the moving party <u>must</u> file a custody action and request mediation before filing a motion requesting relief in Custody Motion Court.

This form is not for requesting that the Court find a party in contempt or enforce an existing custody order. You may seek any other relief you are entitled to under the law in addition to or instead of filing this motion; this may include remedies that could result in relief more quickly than going through Custody Motion Court.

This motion can only grant a temporary Order that will not be binding on your mediation or the Court.

To fill out this motion, you will need:

- The original Complaint's caption;
- The reasons you are filing the motion; and
- What, exactly, you are requesting from the Court.

Instructions:

- 1. When filling out these forms, please write as clearly and neatly as possible.
- 2. Fill out these forms to the best of your ability, completing every line that applies. DO NOT LEAVE ANY LINES BLANK. Use "None" or "0" if necessary. Do NOT use "N/A" anywhere on the forms.
- 3. Check the original complaint to find out who the "Plaintiff" and "Defendant" would be. Be sure the caption is filled out EXACTLY the same; you should always have the same names in the same place on each form in your case. The "A.D." line is for the case number, which was assigned when the original complaint was filed.
- 4. When filling out the Motion [page 3], be specific. On the first block of lines check either the "confirm the status quo" or "address an emergency situation" box, then explain why you want a temporary order on the blank lines. Leave the second block of lines blank; that section is for the Judge's ruling.
- 5. When filling out the Notice [page 4]:
 - a. The first part of the Notice is to set the date of the hearing. Custody Motions Court only occurs on Wednesday, so you must request the hearing for a Wednesday that is at least three (3) days after the day you file the Motion.
 - b. The second part is the "Certificate of Notice and Service". You have to serve the Motion and Notice at least three (3) business days before the hearing. You can choose to mail, hand deliver or fax the Motion and Notice. You should mark your choice and write the date that you will mail, hand deliver or fax the forms.
 - c. The third part is the "Information for Court Administrator". Please read and answer these questions carefully.
 - d. The fourth part is the "Uncontested Motion Certification". Because a motion presented in Custody Motion Court is a contested motion, this section is not relevant to your motion and should be left blank.
- 6. After filling out the Motion and Notice, make three (3) photocopies of the Motion, Notice, and Notice of Language Rights forms. Keep one copy for yourself and serve another copy on the other party as directed in instruction 5(b). Take the third copy to the Intake Window on the fourth floor of the Crawford County Judicial Center by 4:00 p.m. on the Tuesday before your appearance. Bring the original Motion and Notice with you to Custody Motion Court.
- 7. The copy of your motion that you delivered to the Intake Window will be reviewed by a Judge before you go to Custody Motion Court. The Judge will determine whether the relief that you are requesting can be considered in Custody Motion Court based on the information in your motion. If the relief that you are requesting cannot be considered in Custody Motion Court, your motion will be denied and you will need to pursue the other Court remedies that you may have. If your motion is denied prior to Custody Motion Court, you will be called at the telephone number you provided at the bottom of the Notice so you will know that there will not be a hearing. You should notify the other party promptly that there will not be a hearing. If you do not receive a telephone call from the Judge's Chambers you should assume that you will still have a hearing on the day you requested in the Notice.
- 8. During the hearing, both parties will have five (5) minutes to state their side; the person who filed the Motion will go first.


