We encourage you to contact an attorney to advise you on this matter. If you cannot afford an attorney, you may be eligible for an attorney through the Public Defender's Office. You can call them at (814) 333-7367 or visit their office in the Crawford County Courthouse to apply for their services.

You will be required to follow the State and Crawford County Rules of Criminal Procedure and all applicable laws even if you do not have an attorney.

This general motion form is for making requests to the Court regarding your criminal case.

To fill out this motion, you will need:

- The original case's caption;
- The reasons you are filing the motion; and
- What, exactly, you are requesting from the Court.

Instructions:

- 1. When filling out these forms, please write as clearly and neatly as possible.
- 2. Fill out these forms to the best of your ability, completing every line that applies. DO NOT LEAVE ANY LINES BLANK. Use "None" or "0" if necessary. Do NOT use "N/A" anywhere on the forms.
- 3. The Defendant's name should be written on the blank lines on the left side of the caption. Be sure the caption is filled out EXACTLY the same as on the other documents in your case; you should always have the same name in the same place on each form in your case. The "No." line is for the case number, which was assigned when the original case was filed.
- 4. When filling out the Motion [page 3], be specific. First explain what you are requesting from the Court, and then explain why you want your request. Leave the second block of lines blank; that section is for the Judge's ruling.
- 5. When filling out the Notice [page 4]:
 - a. The first part of the Notice is to set the date you will present your motion in Motions Court. Motions Court occurs at 8:45 a.m. every Monday, Wednesday and Friday, excluding holidays; you must request a date for your presentation that is at least three (3) business days after the day you file the Motion.
 - b. The second part is the "Certificate of Notice and Service". You have to serve the Motion and Notice on the prosecuting attorney at least three (3) business days before you present your motion. You can choose to mail, hand deliver or fax the Motion and Notice. You should mark your choice and write the date that you will mail, hand deliver or fax the forms.
 - c. The third part is the "Information for Court Administrator". Please read and answer these questions carefully.
 - d. The fourth part is the "Uncontested Motion Certification". You should fill this section out ONLY if you and the prosecuting attorney agree to the relief requested in the motion. If that is the case, at the top of the "Certificate of Notice and Service" check the line labeled "to the Clerk of Courts as an uncontested matter" and fill in the date you will take your forms to the Clerk of Courts' Office.
- 6. If the Motion is <u>contested</u>, make two (2) photocopies of the Motion, Notice, and Notice of Language Rights. Keep one copy for yourself, serve another copy on the prosecuting attorney as directed in instruction 5(b) and bring the original copy to Motions Court with you on the day you present your argument.
- 7. If the Motion is <u>uncontested</u>, make three (3) photocopies of the Motion, Notice, and Notice of Language Rights. Keep one copy for yourself, serve another copy on the prosecuting attorney as directed in instruction 5(b), take one copy clearly marked "COPY" to Court Reception on the fourth floor of the Crawford County Judicial Center and take the original copy to the Clerk of Court's Office on the second floor of the Crawford County Judicial Center.


