Complaint for Indirect Criminal Contempt of a Protection from Abuse Order

PLEASE READ ALL OF THE INFORMATION CONTAINED IN THIS PACKET BEFORE YOU START FILLING OUT THE FORMS.

THIS PACKET DOES NOT CONSTITUTE LEGAL ADVICE. IF YOU HAVE ANY QUESTIONS ABOUT THIS PROCESS, YOU SHOULD SEEK THE ADVICE OF AN ATTORNEY. THE COURT ASSUMES NO RESPONSIBILITY AND ACCEPTS NO LIABILITY FOR ACTIONS TAKEN BY USERS OF THESE DOCUMENTS, INCLUDING RELIANCE ON THEIR CONTENTS.

We encourage you to contact an attorney to advise you on this matter. If you cannot afford an attorney, the Court will not appoint an attorney for you. You may contact Northwestern Legal Services at (800) 665-6957 or (814) 724-1040 and/or the Crawford County District Attorney's Office at (814) 333-7455 to see if they will provide free legal services to you. They are not obligated to do so.

You will be required to follow the State and Crawford County Rules of Civil Procedure and all applicable laws even if you do not have an attorney.

This packet can be used by Plaintiffs currently protected by a Protection from Abuse (PFA) Order to file for Indirect Criminal Contempt when the Defendant has committed a non-economic violation of any provision of a PFA Order.

If the Defendant has violated an economic condition of the PFA Order, you should use the packet for Civil Contempt of a PFA instead of this packet.

To complete this packet, you will need:

- A copy of your active PFA Order;
- The contact information for the Defendant; and
- At least an hour to complete the process at the Judicial Center.

Instructions (page 1 of 2):

- 1. When filling out these forms, please write as clearly and neatly as possible.
- 2. Fill out these forms to the best of your ability, completing every line that applies. DO NOT LEAVE ANY LINES BLANK. Use "None" or "0" if necessary. Do NOT use "N/A" anywhere on the forms.
- 3. Be sure the caption is filled out EXACTLY the same on each form in your case. Check the original complaint to find out who the "Plaintiff" and "Defendant" would be. The "No." line is for the case number, which was assigned when the original complaint was filed.
- 4. When filling out the "Complaint for Indirect Criminal Contempt for Violation of Protection from Abuse Order" [page 4], only fill in your address in paragraph 2 if your address has not been made confidential by your PFA or other judicial order. If you address is confidential, write "Confidential" on the address line.
- 5. When filling out the "Probable Cause Affidavit" [page 5], please include as much detail as possible about the "Defendant's" non-economic violation(s) of the PFA Order. You should have an independent third party witness your signature on this page.
- 6. The first "Notice and Order to Appear" [page 6], the second "Notice and Order to Appear" [page 7] and the "Warrant of Arrest" [page 8] are for the Judge's use. You should only fill out the caption; print the names of the "Plaintiff" and "Defendant" and write in the case number at the top of the pages so the Judge will not have to do so for any page he uses.
- 7. If you are filing this packet with the District Attorney's Office in the Crawford County Judicial Center, you will take the completed packet to the District Attorney's Office on the first floor of the Judicial Center. 23 Pa. C.S.A. § 6113.1 (a). The D.A. shall forward the "Complaint" and related documents to the Prothonotary's Office on the second floor of the Judicial Center; from there, the Prothonotary will contact the Court Administrator who shall arrange for a Judge to review the "Complaint" as soon as practicable. Craw. Co. L.R.C.P. 1901.5 (3).
 - a. If the Judge finds that there may be grounds for finding the "Defendant" in contempt, he may hold a brief hearing to interview you, set a hearing on the ICC charges, and decide whether or not to issue a warrant for the "Defendant's" arrest.
 - b. If the "Defendant" is arrested, he/she will be brought before the Judge for a preliminary arraignment; the Judge may set a bail amount that the "Defendant" must post to be released from jail.
 - c. After the Judge signs a "Notice and Order to Appear," you must take all the forms to the Prothonotary's Office and file them, then take the copies to the Sheriff on the second floor of the Judicial Center so they may serve it upon the "Defendant."
 - d. If you are granted a hearing on your "Complaint for Indirect Criminal Contempt for Violation of Protection from Abuse Order," your hearing will be set for a PFA Court date within ten (10) days. The Judge will either tell you the date of your hearing, or you will be given written notice of the hearing date on the "Notice and Order to Appear" that the Judge signs. However, that date might change if a warrant is issued. You should make sure the Prothonotary's office has your current mailing address to notify you of any changes. You must appear at the scheduled time or your complaint could be dismissed.

- 8. If you are filing this packet with the Court Administrator in the Crawford County Judicial Center, please give the completed packet to an available Women's Services court advocate or staff member in the law library or Court Administrator's Office. That person will take the paperwork to the next available Judge for his review.
 - e. If the Judge finds that there may be grounds for finding the "Defendant" in contempt, he may hold a brief hearing to interview you, set a hearing on the ICC charges, and decide whether or not to issue a warrant for the "Defendant's" arrest.
 - f. If the "Defendant" is arrested, he/she will be brought before the Judge for a preliminary arraignment; the Judge may set a bail amount that the "Defendant" must post to be released from jail.
 - g. After the Judge signs a "Notice and Order to Appear," you must take all the forms to the Prothonotary's Office and file them, then take the copies to the Sheriff on the second floor of the Judicial Center so they may serve it upon the "Defendant."
 - h. If you are granted a hearing on your "Complaint for Indirect Criminal Contempt for Violation of Protection from Abuse Order," your hearing will be set for a PFA Court date within ten (10) days. The Judge will either tell you the date of your hearing, or you will be given written notice of the hearing date on the "Notice and Order to Appear" that the Judge signs. However, if the Judge issues a "Warrant of Arrest," the hearing date will not be set until the Defendant appears before a Judge for a preliminary arraignment.

IF AT ALL POSSIBLE, YOU SHOULD FILE YOUR PRIVATE COMPLAINT FOR INDIRECT CRIMINAL CONTEMPT IN THE COURT ADMINISTRATOR'S OFFICE IN THE CRAWFORD COUNTY JUDICIAL CENTER IF YOU ARE DOING SO DURING NORMAL BUSINESS HOURS AT THE CRAWFORD COUNTY JUDICIAL CENTER.

- 9. <u>If you are filing this packet with a Magisterial District Judge (MDJ) and this is a Private ICC</u>, you will give the paperwork to the MDJ's staff, who will give it to the MDJ for his/her review.
 - i. The MDJ may hold a brief hearing to determine if there may be grounds to hold the "Defendant" in contempt of the PFA Order. The MDJ will decide whether or not to issue a warrant for the "Defendant's" arrest. If the MDJ does not issue a warrant for the "Defendant's" arrest, an Order will be entered setting a hearing date and time before a Judge at the Crawford County Judicial Center.
 - j. If a warrant is issued a hearing date will be set and when the "Defendant" is arrested, the "Defendant" will be brought before the MDJ for a Preliminary Arraignment. The MDJ may set a bail amount that the "Defendant" must post to be released from jail.
 - k. The MDJ will send your original complaint to the Prothonotary's Office at the Judicial Center and will also notify the Court Administrator so that the hearing can be put on the schedule
 - 1. If a warrant has not been issued for the "Defendant's" arrest you should take your copy of that Order to the Sheriff's Office in the Crawford County Judicial Center so that the "Defendant" can be served with that Order and be made aware of the hearing date and time. If a warrant has been issued by the MDJ and the "Defendant" has been preliminarily arraigned by the MDJ, you do not need to go to the Sheriff's Office because the "Defendant" will be notified of the date and time of the hearing by the MDJ at the Preliminary Arraignment.
- 10. The hearing on your complaint will be held at the Crawford County Judicial Center within ten (10) days of the date you file your complaint, but it may be continued if the "Defendant" is not served. Nonetheless, you must appear at the hearing or your complaint may be dismissed.


