
COUNTY REAL ESTATE AND PER CAPITA TAX FOR THE CITY OF TITUSVILLE

DURING THE PERIOD OF JANUARY 1, 2020 THROUGH DECEMBER 31, 2020, THE CRAWFORD COUNTY TREASURER'S OFFICE COLLECTED \$1,043,513.16 OF THE COUNTY 2020 REAL ESTATE TAX AND \$6,268.15 OF THE COUNTY PER CAPITA TAX FOR THE CITY OF TITUSVILLE. COLLECTED AMOUNTS REPRESENT 87.5% OF THE TOTAL BILLED FOR THE 2020 REAL ESTATE TAX AND 82.5% OF THE TOTAL BILLED FOR THE 2020 PER CAPITA TAX.

D. COUNTY HOTEL EXCISE TAX

CRAWFORD COUNTY COLLECTED \$342,320.65 FROM THE HOTEL EXCISE TAX FOR THE PERIOD NOVEMBER 1, 2019 THROUGH OCTOBER 31, 2020. \$328,627.84 WAS SUBMITTED TO THE CRAWFORD COUNTY TOURIST AND VISITORS BUREAU. A \$13,692.80 COMMISSION FROM THE HOTEL EXCISE TAX WAS EARNED BY THE COUNTY FOR THE PERIOD.
